ACCORDING TO FEEDING TAMPA BAY, 1 IN 4 SCHOOL AGED CHILDREN IN TAMPA ARE HUNGRY, LIVING IN HOMES WHERE FOOD IS SCARCE. THESE CHILDREN RECEIVE MOST OF THEIR MEALS AT SCHOOL AND/OR AFTER SCHOOL PROGRAMS. WHEN WEEKENDS ARRIVE, THESE CHILDREN ARE OFTEN UNDERFED, AND THEREFORE RETURN TO SCHOOL ON MONDAY MORNING HUNGRY, WHICH INTERFERES WITH THEIR ABILITY TO LEARN AND EXCEL. VOLUNTEERS PACK AND DISTRIBUTE BAGS OF NUTRITIOUS FOOD PROVIDING A FAMILY OF FOUR TO EAT BREAKFAST, LUNCH, AND DINNER OVER THE WEEKEND AND SCHOOL HOLIDAYS. CHILDREN WHO ARE SUFFICIENTLY FED DURING NON-SCHOOL DAYS RETURN TO SCHOOL FEELING NOURISHED AND HAVE THE ABILITY TO FOCUS ON LEARNING. DURING THE

DURING THE 2016-2017 YEAR, VOLUNTEERS PROVIDED MORE THAN 1000 "LOVE BUNDLES" THAT WERE DISTRIBUTED BY THE HCSO, AS WELL AS
