



Set's Counch: The Diaper Bank Prepares for the Next Phase of Impact

After seven years, The Junior League of Tampa Diaper Bank is preparing to transition into an independent nonprofit organization. A project that began with a diaper drive to collect 1,000 diapers for inaugural partner Champions for Children, has grown into a complex operation supporting more than 16 organizations and distributing up to 1 million diapers each year.

The recommendation to launch was carefully researched and thoughtfully considered before League members voted to move the Diaper Bank from a JLT project to its own nonprofit. The move



allows the bank to operate with a single focus: combating diaper need in Tampa Bay.

"Our number one priority is to support the Tampa community," said President Nicki Mohr Hall. "By launching the Diaper Bank, we are setting it up to ensure sustainable service delivery and the opportunity to grow with the needs of our community."

BUILDING A FOUNDATION

Success starts with visionary leadership, and the new Diaper Bank organization would need a group of dedicated leaders at the helm. With this in mind, the League brought together a team of community leaders to form an Appointing Committee to recruit, interview and build a Board of Directors.

"I am oversimplifying a complicated process," said Appointing Committee Chair Andrew Smith. "However, the first thing we looked for was capacity. This is effectively a well-funded startup organization that will take many hours of labor over a multiple-year process. If that individual had the capacity, we then vetted for vision. From there, we looked for granularity in strategy and ability to scale. Running a nonprofit takes not only time and vision, but also expertise and ability to meet filing deadlines, organize, and execute." Smith was joined by Adri Colina, Andre Kirwan, Mindy Murphy, Michelle Shimberg, and City Councilman Luis Viera, as well as two League representatives. The team reviewed applications from across the community, conducted interviews, and selected the inaugural board, using their unique perspectives to vet each applicant.

"The vision was to bring together individuals for the Appointing Committee that represented diverse parts of our local public and private sectors," said Smith. "We meshed really well and were able to first rally those in our networks to apply and then respectfully debate best fit through a months-long process of ultimately forming this final board."

The Committee selected a 12-person board, not including a JLT board seat which will be filled by a member of the Executive Board. The dynamic individuals represent a crosssection of the Tampa community, whose passion and influence make them poised to lead the organization into this next chapter.

When asked for his parting advice for the incoming leaders, Smith shared, "Keep questioning the status quo. We have the resources as a society to inspire our neighbors to lift up those who are not as fortunate as they are, to educate them on the many ways to help, and to eradicate poverty. You are the right team, at the right time, to get us closer to this aim."

The new board has already begun preparing for the official launch in January 2025. From developing governance structures to transitioning operations to creating the new organization's identity, the board members have jumped in head first to ensure the new organization continues the effort to eliminate diaper need.

"We are tasked with spreading awareness on the diaper need throughout our community and will help drive fundraising to become a reliable resource for families in need."

CELEBRATING THE MILESTONE

"This is not the end of the League's involvement in the Diaper Bank. It is the next chapter in our collective effort to end diaper need in Tampa Bay," said President Mohr Hall when she opened the Diaper Bank Celebration with JLT's continued commitment to the community. The September 28th event rallied over 250 diaper bank supporters and partners to prepare to officially announce the new organization, the Tampa Bay Diaper Bank.

The celebration recognized the milestone and demonstrated the League's sincere commitment to combating diaper need. Attendees brought thousands of diapers, stuffing a box truck with donations to help the new bank begin operations with a full inventory. League leaders also outlined their plan for funding and volunteer support to help the new organization sustain its operations in the early stages.

"JLT has done a phenomenal job in getting the Diaper Bank to where it is today," reflected Calderelli. "Now, the Diaper Bank has an opportunity to continue to fulfill some basic needs in our community that will help families to thrive and increase its ability to provide critical resources to some of our most vulnerable." Events Manager: Ashley Gabler





A VISION OF LEADERSHIP WITH THE LOVE OF SERVICE AT THE HELM.

For The Junior League of Tampa's 2024-2025 President-Elect Katie Crowe, service to others has always been a leading example.

Looking back, Katie shared a memory of how the League made an impression on her years before stepping into the role of a lifetime. "Growing up, I watched my mom volunteer with the Junior League of Austin and attended events with her both volunteering and at their version of Holiday Gift Market called A Christmas Affair," shared Crowe. "I always knew the League was part of the life I wanted to build for myself." That first impression would go on to motivate her to follow the example set by her mother and join the League.

After being enchanted by Tampa during a visit for her sorority sister's wedding, Crowe, a real estate professional who grew up in Austin, Texas decided she would make Tampa her new home.

In 2015, she became a member of JLT and has served in various roles, including Provisional Project Chair (Kids in the Kitchen), Fundraising Co-Chair (Dragon Boats), Provisional Education Chair, Community Assistance Manager, Community Child Welfare Manager, and Managing Director.

All of these roles, sharpening her leadership skills and cultivating her natural love of community.

While walking with her husband, Crowe received a call that would forever change her trajectory in the League. They announced that she would become the 24-25 President-Elect and lead the organization of motivated women in Tampa who all share a passion for improving the community.

"As soon as they told me I had been selected, I dropped to my knees on the sidewalk and started crying," said Crowe. "It has been such a journey to this point and something I truly dreamed about but never knew if it was possible for me. I was filled with joy and it is truly the most immense honor to be selected for this role."

Regarding her vision for the future, she shared that her presidency will focus on celebrating the last 99 years as the organization prepares to usher in the Centennial in April of 2026. Among her goals are 10 Legacy Projects that will honor JLT's work for the Tampa Bay area over the last 100 years.

Also on the horizon are a Centennial Gala and a reprint of the beloved Gasparilla cookbook.

Located in the heart of Tampa, the League has always been at the forefront of serving the community's needs. Crowe shared that her vision for service in 2024-2025 will be no different, paying homage to the foundation JLT has already laid.

"One community issue that has remained close to my heart is children's mental health," she shared. "Working in this space was something that our members participated in during the 1940s and our partnership with the Hills Guidance Center is something we are excited to explore during our Legacy Projects. I think this is a space that our members can truly appreciate as mental health is an 'issue area' that impacts us all."

Katie's journey is an inspiring reminder to new and seasoned members that everyone can rise to any occasion to make a difference. Her most significant advice to members is to be bold and experience everything.

"The League is a lifetime of membership, and we have so many incredible opportunities and experiences to offer. Take advantage of all of it. Go to every training, apply for every role that excites you, lean in, and soak it all up. The possibilities are endless."

Reflecting on her past and looking forward to the future, Katie shared that she's pulled inspiration from many women she's met while in JLT. The long list of women includes Nicole Hubbard, who served as her President during her first year as an active. Another is Meg Severino, with whom Katie formed a close bond when she served as managing director. Also among the list of women is 2023-2024 President Nicki Mohr Hall, who served alongside Katie as firstyear managers in 2020.

Mohr Hall, now president, who knows intimately about the unique experiences that comes with serving The League as President-Elect, shared that she is excited to witness Katie step into this new phase of leadership.



"I have known very few people who love The Junior League of Tampa like Katie does. Whether you're looking for someone to lead our Provisionals along their journey into the organization, a leader willing to take on any task as Managing Director, or a trusted neighbor to run to headquarters in the middle of the night to make sure there's no storm damage—Katie's your girl," shared Mohr Hall. "She has dedicated so much of herself to JLT because she knows how much this amazing group of women has enriched her life."

With the support of other women in the League and her passion and excitement for serving, Katie's story within the League is still being written. Above all, her vision for this new chapter is something close to her heart: service to others first.

"We rise by lifting others," said Crowe. "I'm a strong believer in servant leadership and pouring into those that will come next, just like my mentors have done for me. I love seeing our members take the time to raise other members, and I know that continuing to do so will only strengthen the amazing culture we have here in the League."

It was a rainy Tuesday afternoon that Miranda was able to set aside time for her to share her wonderful Junior League Journey thus far with me. We spoke of her career, military service, family, and the impact the League has had on her both personally and professionally. Please enjoy getting to know her in-depth as I was able to.

WHAT IS YOUR PROFESSIONAL POSITION?

I am a Program Manager at SAIC, a premier IT company within the defense, space, civilian, and intelligence markets. For more than 18 years, I have taken on operational and strategic roles of increasing responsibility such as, leading teams of tech experts to assist our military personnel in the U.S. and Middle Eastern countries. Two years ago, I pivoted into the State and Local services sector, and I recently achieved another huge career milestone by becoming a Program Management lead overseeing the State of Colorado's Department of Human Services Office of Information Technology.

WHAT INSPIRED YOU TO START IN THAT CAREER FIELD?

Prior to joining SAIC, I served in the U.S. military as an Intelligence Analyst and lived abroad. I was inspired to work in the Defense sector and realized that being in military intelligence was critical to our national security. I joined the military after a significant period in our nation, following the September 11th attacks in New York and Virginia. After I completed my enlistment, I used skills in which I honed as an Intelligence Analyst and transitioned into a technology career at SAIC and settled down in Tampa where I had an opportunity to attend graduate school and start a family.

WHAT POSITIVE CHANGES OR PROJECTS COME TO MIND WHEN YOU THINK OF JLT?

I have an admiration for the League's dedication to Diversity, Inclusion, and Belonging. Throughout my time with the League, I have noted considerable progress in the inclusion of women and meeting them at various stages of their lives. Speaking of projects, one of my fondest memories was as a provisional, Kids in the Kitchen was the project, aimed to teach children how to cook nutritious meals by bringing the League into classrooms. Although it is now a sunset program, I loved the collaboration between our volunteers and the ways in which we were able to connect with the kids at a level which was easily digestible. Another favorite project of mine is MILO, which stands for Mobile Interactive Literacy Opportunity, as it is directly tied to children's literacy and reading books is a personal favorite pastime.

WHAT WAS THE MOST IMPORTANT ROLE YOU HELD IN THE LEAGUE?

I am a former Managing Director, and former member of the Executive Board. I led a diverse group of managers at various stages of life at the league. At that time, I was also losing a very close family member, and I must say that those moments of leading and being inspired by our impact also helped me cope. I found completing multi-year operational timelines and projects within just one year to be nearly impossible, yet rewarding, as progress was made bit by bit. Despite the hurdles, it is important to appreciate the collective effort each manager contributed which kept the momentum going. All the amazing work achieved in such a brief period is because of dynamic women coming together on one accord and making it happen. The late nights, the tears, the Ah-ha moments, the life lessons are all such valuable nuggets. It was all so very impressive but also bittersweet; I truly cherish the time spent leading alongside those powerhouse group of women!



HOW IMPORTANT IS MENTORSHIP WITHIN THE LEAGUE? DID YOU HAVE A MENTOR? WHO RECRUITED YOU TO JOIN? HAVE YOU MENTORED PEOPLE?

Mentorship plays a crucial role within the Junior League. Reflecting on past best practices to pave the way for improvement and lessons learned is key. Quick leadership decisions can be challenging but necessary, a good mentor is key during situations like this. Mentorship is vital for personal growth within the League. I have had many mentors throughout my league career including past presidents and active members who have provided valuable guidance to me, some who have become such special friends. I was recruited by a dear friend at work who is also a League member. Yes! I have mentored individuals and will continue to do so, inspiring them to strive for leadership roles or just to stay within the league and I am so happy to see them shine and continue to reach for greatness.

SUSTAINER SPOTLIGHT

Mindy J Murphy

Building community is at the heart of everything Mindy Murphy does. As a JLT Sustainer and President & CEO of The Spring of Tampa Bay, Mindy's approach to mentorship is intentional and impactful. We caught up with her to learn more about her League journey and what being a mentor really means.



WHAT INSPIRED YOU TO JOIN JLT?

My earliest memories of volunteering are tagging along with my mom, first in Kansas City, then Cincinnati, as she served in various leadership roles with Junior Leagues in both cities. Growing up watching my mom lead significant city-wide initiatives through her League service in the 1970s and 80s (and all the way into the 2010s!) taught me that women can do anything, and we often do it exceptionally well.

HOW HAS JLT ENHANCED YOUR LIFE, PERSONALLY AND PROFESSIONALLY?

I was proposed by League members in Cincinnati right as I graduated from UVA and was a Provisional Transfer to the JLT. I barely knew a soul when I moved to Tampa in September 1990, and my 1991-1992 Provisional year was a fantastic way to meet friends and learn about our amazing city. As I took on progressively more responsibility within the JLT, I had a chance to showcase my skills to folks in the nonprofit sector, and I fully believe my professional roles at The Spring and, previously at the Child Abuse Council (now renamed Champions for Children), were a direct result of the skills I learned and the leadership I showed in the League. I would say the same concerning the various roles I've held on nonprofit boards of directors over the years.

Personally, many of my closest friends I first met through the Junior League – or proposed for the League so they could be part of our mission and part of our fun! There are 18 of us who have gathered to celebrate our birthdays, weddings, babies, and promotions, and held each other close through divorces and family deaths, for more than 20 years now. Affectionately known as "Birthday Bounty" we meet monthly and text often and I cherish this group of friends who have mentored me and been mentored by me over these many years.

WHAT WAS THE MOST IMPACTFUL ROLE THAT YOU HELD IN THE LEAGUE?

I loved every role I held – from chairing the Hospice Camp Circle of Love bereavement camp to leading the Provisional program to being the JLT Thrift Sale Co-Chair and sweating through warehouse shifts with everyone. Being the Community VP was meaningful because my reason for joining the League has always been grounded in community service.

However, the role I learned the most from was serving as the League's President in 2001-2002 at the tender age of 33 when the world changed overnight in response to the September 11th attacks, and our major fundraising event was scheduled for that month. I would imagine the League Presidents and leaders who recently served as the pandemic unfolded felt much the same as I did, trying to lead calmly during chaos and sadness, and still move the League's mission of service to our community and to our members forward in an impactful way. There were moments I felt very alone that year, and then we turned the corner into 2002. We gelled as an Executive Committee and got stuff done. As I've aged, I've continued to reflect on that year and incorporate what I learned from those challenges and successes into how I lead today.

HOW IMPORTANT IS MENTORSHIP WITHIN THE LEAGUE?

Mentorship is critically important! So many people believed in my ability to lead a committee or lead the League, long before I believed it myself. They challenged me while supporting me with training opportunities and tips. I also think it's important for mentorship to extend beyond League service and into the community and professional landscape.

I love hiring League members for fundraising roles at The Spring. Both Maggie McCleland, our current Chief Advancement Officer, and Ellen Boczarski Lynn, her predecessor, are members of The Junior League of Tampa and brought all that they learned into their work for The Spring. The extraordinary Lauren Rice, who recently chaired Holiday Gift Market, is the Administrative Supervising Attorney within The Spring's Legal Services Division. She showcases her League skills each day as she represents survivors of domestic violence in court. When you work with a League member – or recommend them for a job or a board – you can feel confident they'll come highly trained and ready to give their all to the work at hand.

TELL A TIME WHEN YOU FELT POSITIVELY IMPACTED A MEMBER.

The amazing Renee Dabbs, Sustainer extraordinaire, will always be the first person I think of in this regard. She is a huge supportive presence and cheerleader for her League friends and gives meaningful, strategic guidance every step of the way when I run into a challenge or need to make a tough decision. She coined the phrase, "turn and pull" to describe her philosophy of how women should support each other, and she's demonstrated it every day I've known her.


She also once said, offhand, "my friend bucket is full" but will insist she didn't! It has, however, stuck with me ever since – not so much in a literal sense because I've added many friends over the years, but as a reflection on how I think about taking on any new responsibility (and friends and mentees ARE a responsibility). We each have the same 24 hours each day, and we need to use this time in ways that bring purpose, meaning and joy into our lives.

WHAT ADVICE WOULD YOU HAVE FOR NEWER MEMBERS?

Take full advantage of all the League has to offer. Try something a little outside your comfort zone. When you say yes to something, be prepared to give it at least 100%. And it's okay to say no if the time isn't right for you or your family. The League will still be here when you're ready. Be of service in all you do and have fun while you're doing it.

Three-Layer Chocolate Cake

- 2 cups sugar
- ¾ cup butter
- 3 eggs
- 5 tablespoons cocoa
- 3 cups flour
- 1 cup buttermilk
- 1 teaspoon vanilla
- 1⁄4 teaspoon salt
- 1 teaspoon soda

Cream the sugar and butter. Add unbeaten eggs and mix. Dissolve the cocoa in 2 tablespoons hot water and add to mixture. Add alternately the flour and buttermilk and mix. Add vanilla and salt. Add soda dissolve in 3 tablespoons hot water to mixture and bake into 3 layer-cake pans, 30 to 35 minutes at 350 degrees. Frost with Mocha Cake Icing.

UNCOOKED MOCHA CAKE ICING:

- $\frac{1}{2}$ cup butter
- 2 cups powdered sugar
- 3 tablespoons cocoa
- 2 tablespoons cold coffee
- 1 teaspoon vanilla
- 1 egg white
- 2 or 3 teaspoons sweet or sour cream (optional)

Cream the butter and sugar. Add cocoa and coffee, when vanilla. Next add unbeaten egg white. If this mixture is too thick, add a few tablespoons of thick sweet or sour cream. Spread on cake.

Orange Cupcakes

- 2 2/3 cups flour
- 4 teaspoons baking powder
- 1/4 teaspoon salt
- 1 ½ cups sugar
- 1/3 cup evaporated milk
- 2/3 cup orange juice
- 2 eggs, beaten
- 1/2 cup soft butter

Combine and sift dry ingredients. Add milk, orange juice, eggs, and soft butter to dry ingredients. Stir until well mixed. Bake in paper cups at 400 degrees (put paper cups in muffin pans). Ice while warm.

ICING:

- 1 tablespoon grated orange rind
- 1 tablespoon evaporated milk
- 2 tablespoons orange juice
- 1/4 teaspoon salt
- 2 cups of confectioners sugar (or just enough to thicken icing to spread on cakes)


