Today, our 14 partnership projects and community outreach events work to address child welfare and education in an immediate way, while our advocacy efforts seek to affect positive change on a local and state level.

With 141 new members and more than \$715,000 raised in 2015-2016, the League continues to impact Tampa Bay in a significant way. Internally, the League optimized our leadership structure with the implementation of a Management Council. DAN SCOTT

IMPACTING LIVES IN THE COMMUNITY

21 year old Dan Scott is one of the thousands of children touched by The Junior League of Tampa; his inspirational story highlights the lasting impact made by our work in the community. Dan is now on the path of success. The League first met Dan as a young foster child who was separated from his sister Shartanay at an early age. He struggled with loneliness and felt like he didn't belong, which impacted his school work and focus. The Junior League of Tampa invited Dan to attend its Kids Connect adoption events, providing him with the opportunity to see his sister. Attending these events for over 7 years, Dan got the chance to reconnect and maintain a relationship with Shartanay and to meet other foster children in similar situations.

"I felt really happy and proud seeing my sister because I couldn't see her every day, seeing her at these events just brought a smile on my face always. We loved taking photos and being silly in the photo booth and eating together. We spent most of our time just talking and catching up. I am so thankful for the Junior League connecting me to Shartanay."

Today Dan is balanced, happy and hopeful with a bright future ahead of him. He lives independently and is enrolled at Hillsborough Community College seeking his EMT certification and hopes to become a firefighter. Dan has a great relationship and a strong bond with his sister; they support each other, spend a lot of time together and eat dinner as a family often.

The Junior League of Tampa is able to positively affect and transform the lives of children like Dan by focusing on niche areas that are not being addressed by others in the community.

OUR NEW COMMUNITY PROJECT: MILO

This year The Junior League of Tampa added a new component to its Literacy projects: MILO (Mobile Interactive Learning Opportunity). In May 2016, we began hosting mobile monthly literacy events throughout Hillsborough County in partnership with the Tampa- Hillsborough County Public Library, the Children's Board of Hillsborough County and WEDU PBS. The MILO bus visits underserved locations providing books, literacy activities, opportunities to meet PBS characters,

and book readings for children ages 3 to 8. League volunteers also give out books, educate families on the importance of literacy and introduce resources available to them.

CHILD WELFARE



H.E.A.R.T. (HELPING EVERY ADOPTABLE CHILD RISE TOGETHER)

Since 2011, we have worked with the Children's Board Heart Gallery of Tampa Bay to provide birthday parties and quality of life events for youth in foster care. Our volunteers bring personalized celebrations to children who wouldn't otherwise have this experience and often times this is the first birthday party they have had. In addition, our volunteers hold group photo shoots for the Heart Gallery exhibit, providing siblings living apart an opportunity to reconnect and spend time with one another.



KIDS CONNECT

In partnership with Camelot Community Care, Kids Connect is one of JLT's longest standing projects where foster children available for adoption can meet with prospective families, and interact in a fun, low-stress environment. Since 1996 we have assisted more than 160 children find a forever family.



LOVE BUNDLES

In coordination with Eckerd Kids and the Hillsborough County Sheriff's Office, our volunteers pack thousands of backpacks containing essential clothing, toiletries and comfort items to children entering foster care with little or no belongings. Since 1996, Love Bundles has focused on providing backpacks to children within the first 24 hours of removal from their home due to neglect or abuse. This year the committee distributed 995 backpacks to children in need and they also partnered with Eckerd to provide a closet of clothing and other essentials for children transitioning between foster care families.



READY TO ACHIEVE

Since 2007, The Junior League of Tampa has worked with youth aging out of foster care and provided events to ease their transition into independence. These events focus on life skills, parenting, nutrition and other issues to improve quality of life. This year, the committee hosted five events in partnership with Eckerd Kids and Camelot Community Care: a sibling reunification event, a Shop & Show for interview clothes, a cooking demonstration, a Mommy & Me class, and graduation. The committee also hosted a holiday party for Starting Right Now.



HUMAN TRAFFICKING AWARENESS

The committee focuses on advocacy and training that bring awareness to the issue of human trafficking in Tampa Bay. In 2016 The Junior League of Tampa provided volunteers for the local candlelight vigil and the Human Trafficking Summit, hosted a free screening of the documentary In Plain Sight and volunteers created Easter baskets for human trafficking survivors. A training event was held to educate League membership and the community on prevention and awareness of this issue, featuring a detective of the Tampa Police Department who has worked in the human trafficking field for decades.

EDUCATION

FOOD 4 KIDS

The Junior League of Tampa partnered with Feeding Tampa Bay in 2009 to build and sustain a “backpack” program established to keep hunger at bay on weekends. The Junior League of Tampa supplies over 400 bags of nutritious food to disadvantaged children every Friday during the school year. With over 11,000 bags given out this year, this food is intended to sustain these children over the weekend when they are not receiving their meals from school. In addition to the regular distributions, the committee also hosted three mobile food pantries throughout the year.



KIDS IN THE KITCHEN

The Junior Leagues' Kids in the Kitchen initiative was created by the Association of Junior Leagues International (AJLI) with the goals of empowering youth to make healthy lifestyle choices and helping reverse the growth of childhood obesity and its associated health issues. League volunteers work with elementary school youth to introduce them to better nutrition, improved fitness and cooking their own food. The Junior League of Tampa adopted Kids in the Kitchen in 2006 as the official training project of each year's Provisional Class, providing incoming members the opportunity to plan, lead and participate in a large scope community program. This year over 127 Provisional members volunteered at seven local after-school centers, impacting over 1,200 youth.



GIRL POWER!

The Junior League of Tampa volunteers host monthly activities with teenage girls, ages 13 to 17, at the foster group home, Joshua House. This Girl Power! project is going into its fourth year and on average serves 20 girls year round. The goal of the project is to have a deeper impact with the young ladies of the next generation by offering mentoring, motivation and education through activities which focus on literacy, scholarship, nutrition, and positive self-image, as well as important topics such as personal hygiene.



LUMINARIES

The Junior League of Tampa created The Luminaries, in partnership with WEDU PBS, as an annual recognition program to showcase outstanding individuals who have, through their inspiring leadership, empowerment or advocacy made a lasting impact on the Tampa community. The 2016 honorees were Celia Ferman, State Senator Arthenia Joyner and Lincoln Tamayo, who all have achieved exceptional prominence or distinction in a particular sphere. The Luminaries leadership award program takes recognition a step further by capturing and preserving the influential stories of the award recipients through the creation and distribution of digital media biographies, which are presented at the Award Ceremony and are made into a program to broadcast on WEDU PBS and displayed on the WEDU PBS website. In addition, DVDs of the program are distributed to educators, colleges, civic groups, and libraries for educational purposes.



CHILDREN'S LITERACY PROJECT

Since 1999, League volunteers have read to kindergarteners in Title I Schools to promote literacy skills, and distributed tens of thousands of books to the children to build their home libraries. Volunteers read to students in five partner schools, serving 19 classrooms with over 400 children and handed out over 9,000 books over the course of the year.



FAMILY LITERACY NIGHTS

Family Literacy Nights served 965 children through 15 literacy nights hosted at five Hillsborough County Title I Schools. Over the course of the year, League volunteers distributed 1,230 books, 450 bags of take home food, and 75 teacher supply bags/gift cards to teachers.





DRAGON BOAT FUNDRAISER

We are excited to announce our new signature fundraiser to debut in April 2017. The Junior League of Tampa, with the help of Sustainer Beth Schatzburg and her Blue Dragon colleagues, has developed a partnership with Tampa based Pan Am Dragon Boat Association, a leading dragon boat production company.

The Junior League of Tampa will be Pan Am's exclusive 501(c)(3) beneficiary of the Tampa Bay International Dragon Boat Races for multiple years starting in 2017. This fundraiser offers the League an opportunity to build a signature event in the Tampa Bay area.

The event will be held at the Cotanchobee Fort Brooke Park, a beautiful waterfront park located along the Garrison Channel in downtown Tampa. The channel will come alive with dragon boat racing that includes participants who are community paddlers, corporate paddlers, and professional paddlers. All age, skill levels, and physiques can join in. The Junior League of Tampa will use this event to highlight "health and wellness" in our community, with great opportunities for sponsorships, volunteering, family participation and merchandise to purchase. All net proceeds will support the League's community projects and programs.

AJLI WINTER CONFERENCE IN TAMPA

The Junior League of Tampa is proud to host the 2017 Winter Leadership Conference of the Association of Junior Leagues International in January 2017. Over 350 leaders of Junior Leagues across the country will gather in Tampa for a long weekend of leadership training. Conference workshops are designed to deliver the skills and tools attendees need to lead their Leagues and explore other aspects of civic leadership for greater impact.

ADVOCACY

DRIVING CHANGE IN OUR COMMUNITY

The Junior League of Tampa has a long history of advocating for the betterment of the community. Our Public Affairs Committee plays an active role in informing and educating League Members and the public about legislation that affects our issue areas on both a local and state level. We are active members of the Junior Leagues of Florida State Public Affairs Committee (SPAC), which represents 25 Leagues and over 11,000 women from across the state. The group takes action on state and national issues that affect our projects, priority issue areas and communities, primarily by supporting legislation that are identified as being critical to the work of member Leagues, community partners, and the lives of Florida women, children and families.

Many of the laws we take for granted originated with an idea that was first proposed by the Florida SPAC made up of Junior League members. Some of the issues tackled over the years include a law requiring safety seats in motor vehicles for children between ages 4 and 7, two bills by Florida State Senators requiring proper documentation for noncitizen workers in massage parlors and mandating safe harbor for sexually exploited children and state support for gender-specific programming for girls detained in the juvenile justice system.

The Junior League of Tampa also helped pass legislation which expunges the criminal record of human trafficking victims. Before this legislation, human trafficking victims, including children, were often re-victimized by being labeled as criminals, which kept them from receiving the type of help and support needed to be liberated from their illegal bondage.

FALL SPAC CONFERENCE IN TAMPA

The Junior League of Tampa was chosen to host the 2016 Fall Conference of the Junior Leagues of Florida State Public Affairs Committee, held September 16-18, 2016 at The Junior League of Tampa Headquarters. Main focus areas will include Education, At-Risk Youth, Health and Hunger, and Community Safety. The conference will feature a special panel discussion highlighting the process of "Women Running for Office", with a purpose of encouraging more Junior League members to consider an elected position or to become part of the campaign process.



FEATURED COMMUNITY PARTNER

COMMUNITY OUTREACH

The Community Outreach committee works with community partners to host various events focused on child welfare and literacy. In its inaugural year, the group hosted eight events, including four events new to The Junior League of Tampa. Events ranged from the Adoptive Family Picnic serving 40 children and their families to a back to school event in Sulphur Springs where 266 backpacks containing school supplies were distributed. The largest event held by the Committee was the third Annual Family Food Fest, a free event which brings many of our community projects and partners together to serve the Sulphur Springs community by providing healthy food and encouraging healthy lifestyles. Family Food Fest was initiated by The Junior League of Tampa in 2014 with a goal to reduce the impact of the “summer slide” into poor nutrition and reading loss as children recess from school for the summer. This event focused on encouraging the community to maintain a healthy lifestyle, along with highlighting the importance of literacy-based activities in their children’s schedules so they do not lose momentum for the fall school semester.



ABOLISH

Raising awareness about Human Trafficking in Tampa Bay

The Abolish Movement was initiated by The Junior League of Tampa in partnership with the FREE Network and created by Ad2 Tampa Bay as a unified public awareness campaign meant to bring an end to the Child Sex Slavery epidemic in the Tampa Bay area through education, prevention, support services and legislative advocacy. The movement launched in January 2014 and united 100+ agencies and organizations in Hillsborough, Pinellas and Pasco counties.

The Junior League of Tampa believes that only through awareness can change occur. The Abolish campaign aims to raise community awareness of the scope of the problem; empower the community to report suspicious activity; and reach victims who need to know where to go for help.



CELEBRATING OUR 90 YEARS OF SERVICE IN THE COMMUNITY

Since its founding in 1926 by 22 visionary women, The Junior League of Tampa has evolved into one of the oldest, largest and most effective women's volunteer organizations in the Bay area. Today, more than 1,900 members provide over 50,000 volunteer hours to 14 community programs, ranging from child literacy and nutrition to adoption and the fight against human trafficking.

Just as our community's needs have evolved, The Junior League of Tampa has also evolved to meet those needs, while the core values of our organization have remained constant throughout the years. The commitment to improving our communities through effective action and the development of trained volunteers has always been our mission.

The community needs decades ago were not so different from today's. Several of Tampa's leading nonprofit programs and organizations today were original volunteer projects of The Junior League of Tampa, or were founded by League members, including: Mary Lee's House, Baby Bungalow, MacDonald Training Center, MORE HEALTH, Inc. and Champions for Children.

90TH ANNIVERSARY LEGACY PROJECT

As The Junior League of Tampa embarks on its 90th year, we have a unique opportunity to commemorate the nine decades of service that the League has had in our community by honoring all different aspects of our three part mission: voluntarism, developing the potential of women and community impact. Through the lens of voluntarism, The Junior League of Tampa will be partnering with previous community partners to plan 9 done-in-a-day service projects, many of which began as original League volunteer projects. This Legacy Project will highlight an issue or partner we have worked with in each of our last 9 decades.

The League kicked off the Legacy Project with the Glazer Children's Museum, a longstanding partner of the League, during Child Abuse Prevention Month, an issue that has been the focal point of much of our work for decades. The 90th Legacy Project committee continued by helping launch MILO, our Mobile Interactive Literacy Opportunity bus in partnership with the Hillsborough County Library System, WEDU PBS, and the Children's Board. Through the League's donations, MILO, our signature 90th community project is helping children build home libraries in underserved communities.

The most recent Legacy Project was a leadership development institute in partnership with Academy Prep of Tampa. Thirty plus middle school students learned

about the importance of giving back and having a personal mission statement to guide their life. Three Sustainer and two Active members participated in a moderated panel looking at the importance of mentorship, being true to one's self and following interests and passions well into adulthood, while always keeping an eye to the importance of reaching back and pulling forward the next generation of leaders.

Throughout the 2016–17 year, the 90th Anniversary Legacy Project Committee will continue with six additional projects ranging from child abuse prevention, health and injury prevention, and a tribute to military veterans.

The Legacy Project will provide our members with additional volunteer opportunities, as we challenge our entire membership to donate 90 volunteer hours in our 90th year.

Every project serves as a reminder of the League's past. Hundreds of thousands of volunteer hours were donated, our community and the lives of our citizens were impacted and highly skilled women leaders have emerged. It's through the 90th Anniversary Legacy Project that we celebrate and remember the 90 impactful years that the League has had in our community and will continue to have for many years to come.



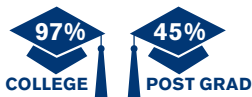
DEVELOPING THE NEXT GENERATION OF LEADERS

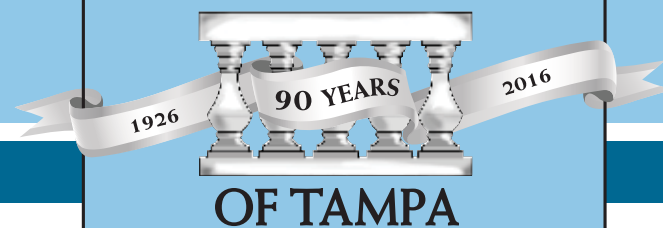
